I. CALL TO ORDER

There being a quorum, the meeting of the ATOSSCOM Annual Conference was called to order at 1:35 p.m., Wednesday, August 1, 2018. Present at the meeting were:

II. ADOPTION OF MINUTES

VI. WATER TRANSPORTATION TRAINING PROGRAM

Secretary Santos mentioned that the Water Transportation Training Program was made possible through an MOU by and between the parties of ATOSSCOM, Port Authority of Guan, Matson Navigation, and Marianas Steamship Agency which was executed on May 2018. The MOU allows for two (2) trainee slots to be trained for four (4) consecutive weeks. He stated this year's training program took place July 2-27, 2018 and the trainees that participated were from Pohnpei Port Authority John Ezekio and Saipan Stevedore Company John Acosta. The trainees were housed in *Inn on the Bay* at the village of Agat. The training program exposed the trainees to the processes of the warehouse, gate operation, terminal layout and operation, vessel tour, safety briefing, cargo handling and equipment operation.

Saipan Stevedore Company Assistant General Manager Lee Cabrera thanked ATOSSCOM and parties for the opportunity of allowing their employee John Acosta to participate in the training program. He understands that the training program provided Mr. Acosta with a firsthand experience in the Port of Guam operations which will serve beneficial to the Port of Saipan. Mr. Acosta shared his learning experience on the Port of Guam issuing, loading and the different levels of operating the equipment against cargo. Secretary Santos mentioned that Certificates of Completion have been prepared for the two trainees.

- 1. **Next Training Program Participation**: Secretary Santos said the participants for the next training program are representatives from the islands of Yap and Chuuk. He reminded those present about the 'Participation Criteria' of the Water Transportation Training Program, which states in part:
 - Must be a Terminal/Stevedoring Company
 - Must be a Regular Member for a minimum of five (5) years
 - Must be in good standing with the association for five (5) consecutive years
 - Trainee fills out Trainee Application Form and sends a copy of the form to include a copy of his/her passport via facsimile/email to the Port Authority of Guam one (1) month in advance of schedule training date.
 - Upon receipt of the trainee application a copy of the signed MOU by the Guam based sponsor members and a copy of the Indemnification and Hold Harmless Agreement form will be sent via facsimile/email to the Agency/Company providing the trainee and the trainee to sign and acknowledge. Agency/Company to send completed forms back to PAG via facsimile/email for processing.
 - Guam based sponsor PAG will request from the ATOSSCOM Board Treasurer for check disbursement for per diem in the name of the trainee.
 - The per diem will be in the amount of \$980.00 = 28 days x \$35.00 for two (2) trainees \$1,960.00 for the training period to cover meals, land transportation, and miscellaneous expenses.

Motion was made by Commonwealth of Ports Authority to accept the Financial Report as presented, seconded by Palau Shipping Company. Motion was unanimously approved.

X. ELECTION OF OFFICERS

1. **Nomination for President and Vice President:** Secretary Santos explained that nominations will be made for the companies rather than individual nominees. If accepted, such company will decide within their organization who will serve as the ATOSSCOM Executive Officer. The floor is now open for nominations.

Saipan Stevedore Company was nominated as the President. Majuro Stevedore and Terminal Company was nominated as the Vice President. Motion to close the nomination was made by Matson, seconded by Majuro Stevedore and Terminal Company. Motion was unanimously approved. Election of Officers as accepted for President is Saipan Stevedore Company and for Vice President is Majuro Stevedore and Terminal Company.

XI. NEXT MEETING SITE (2019 & 2020)

Secretary Santos mentioned that normally ATOSCCOM Annual Conference is held in conjunction with the Micronesian Shipping Commission (MSC); however, this year was not the case due to prior obligations of the ATOSSCOM Executive Officers. He stated that Article VI of the Constitution indicates that the association shall be at such interval and at such times and places as may be provided by the By-Laws; provided that in the case of emergency the President may cancel; postpone or change the date or place of holding a conference. Secretary Santos further stated that Section 18 of the By-Laws indicates that the conference of the association shall be held at least one time per year, so as far as practicable, and at such time and place as

shall be determined by the Executive Committee. Such determination shall be made not less than three months prior to holding of such conference. The Secretary, or the designated conference Chairman shall within one month after its preparation and approval, advise all members in writing of the proposed conference agenda as determined by the Executive Committee.

He mentioned that in moving forward and to ensure the working relationship with MSC that every effort is made to hold the association's annual conference in conjunction with MSC where practical. Majuro Stevedore and Terminal Company made motion for the ATOSSCOM Executive Officers to coordinate with Micronesian Shipping Commission on the next annual conference meeting schedule for the years 2019 and 2020. Motion was seconded by Truk Transportation Company and was unanimously approved.
